1. Introduction

This report is a year to date report. The YM G being a mission group of the MCSA, operates under the MCSA auspices. The YM G is by extension an arm of the church whose purpose is to assist the MCSA towards social impact and transformation by evangelising Christianity; bringing people closer to God and also taking God closer to people.

This is achieved through the YM G activities in and outside of the church. It's also achieved the YM G's impact through existing Church activities.

Through its activities, the YM G is the church's tool for social transformation and healing. Mainly within men and through men.

2. Life of YM G Members

- 2.1. The YM G had only two activities in 2025. The main purpose of these events was to raise funds for the YM G mission. It was also to evangelise and have social impact.
- 2.2. We successfully hosted our annual International Women's Gala Dinner on the 8th March. It was a success in that the event took place with good attendance. But as a fundraising event, it was unsuccessful. The financial report below will show that YM G made a R35K loss on the event.

The main contributing factor to the loss was the late marketing resulting in an inability to raise sponsorship. We started in February with marketing of this event. This did not leave us with anytime to source sponsorships and to sell tuckets. With ticket prices costing at least R400, we could not sell enough tickets to pay for themselves, and also couldn't raise enough sponsorships to fundraise.

If this event is to be a success in 2026, we need to plan better and start planning within 2025, or else consider not hosting it.

- 2.3. On the 27 August, the YMG hosted its inaugural Golf Day. The purpose of this particular Golf Day was to test the waters. There was a very healthy response to the Golf Day. It was held at the Wanderers Gold Club. There were 57 golfers who partook in the Golf Day, at a fee of R500 per player. A number of people and companies sponsored for people to play, without playing themselves. This is promising for the future of the Golf Day in coming years. In the end, the YMG raised a net profit of R3000 for the golf day. Below are some pictures of the day.

This number makes it impossible for close relations amongst members generally, and with the Exco specifically. Thus members have been grouped under an Exco member. 3. Manyano Meetings

- 3.1. The Fourways Circuit YMG theme launch was done on the 23 February which set the tone for 2025.
- 3.2. As BMC YMG our theme launch was also performed in February under the theme “Becoming and alternative Community”.
- 3.3. Manyano continues every Sunday since opening. It is worth noting that attendance at our Manyano is ‘unhealthy’, with an average of 10 – 15 members at every meeting when contrasted with total membership of above 60. It would be ideal to have at least 20 members at Manyano every Sunday.
- 3.4. We had a street revival in Lanseria on the 13 April during the Palm Sunday weekend. This was in support of Lanseria as our preaching place. Two follow up Manyano meetings were held in Lanseria in line with the our year plan.
- 3.5. On the 30th March, we had a special General Meeting, whose purpose was to screen on trial members who were due for robing over the Easter weekend. This was done successfully.
- 3.6. We have one YMG member in Lanseria, Brother Moagi. Our Exco plan of having brother Moagi visit us at BMC once a month has not materialised. This has been due to availability. This plan is there to ensure that bro Moagi is effectively integrated into BMC. This plan needs to be revisited.

4. Membership

- 4.6. We had five members transferring into BMC this year, with one member transferring out.
- 4.7. Thus, it is safe to conclude that our BMC membership continues to grow.

- 4.8. We have encouraged members to start subscribing for 2026 already in Q3 of 2025. This is to allow enough time to plan financially so that by end of February 2026 we have a fully subscribed membership. A decision has been made by EXCO to increase the 2026 subscription fee to R950, a marginal increase from the R880.
- 4.9. As per section 5 in the YMG constitution, membership of the YMG is based on
- Diligent attendance of YMG Meetings
 - Spiritual maturity
 - Active participation in all YMG activities
 - Full membership of MCSA (being active member of a class)
 - Paying due subscriptions.

As a body of members we have historically been weak with two aspects of these requirements:

- **Diligently attending YMG meetings** and
- **Active participation in YMG activities.**

This is a weakness that confronts the EXCO, but needs all YMG members to meet individually. It talks to our commitment as a YMG body at BMC.

5. YMG Activities

- 5.1. Manyano was official opened on the 19th January and the Theme Launch on 16th February. The theme for 2025 is “Becoming and Alternative Community”. We had very healthy attendance at both events, where our members showed in healthy numbers. We had over 30 members in attendance at both events, which is a very good showing. YMG members deserve to be commended for this.
- 5.2. General meetings continue as planned every quarter. We have had three meetings so far in 2025. Our final meeting will be on the 29th November.
- 5.3. The YMG hasn’t held its normal outreach programs in 2025. This has been due to lack of funding and member support.

6. Financial Report as at 31 October 2025

Highlights:

1. R62 000 generated for the Rhona fundraising event held on the 26 of October 2025. Actual amount received was **R51 000** and **R11 000** was raised through pledges (pledges are expected to be settled by no later than the 30 November 2025). The event was a resounding success testament to the fact that early planning will always yield positive results.
2. During the year 63 members have affiliated with the total amounting to **R54 440**.
3. Of this amount of **R29 900** was paid over to the circuit as part of assessment fees.
